Ms. Brooks serves as the state's Senior Housing Policy Advisor and leads the work of the MassHome team. As Director of the Department of Housing and Community Development, she manages a budget of over \$680 million. DHCD provides leadership, technical assistance and financial support to advance the development of affordable housing and the economic vitality of communities statewide. Ms. Brooks serves on the boards of MassHousing, Massachusetts Housing Partnership and CEDAC. She came to state government following over 15 years in affordable housing and community development, much of it in her native Philadelphia. She began her career in landscape architecture and planning.

Eleanor White is the President of Housing Partners, Inc., a Boston area-based national housing consulting and asset management firm she formed in 1995. Ms. White has worked in the fields of affordable housing development, property asset management and public administration since 1967, including a 12 year term as Deputy Director and Chief of Operations of the Massachusetts Housing Finance Agency (now MassHousing). She has served and currently serves on numerous boards and has received many awards and recognitions for her outstanding work in her field.
